#### THE APPLICATION PROCESS

We require that all prospective tenants meet the qualifications of the following:

### **Income/Employment Verification**

You must be able to verify, through documentation, that your Net income is at least 3 times the rent of the property you are applying for.

For most applicants, we verify income using your last 3 pay stubs, written employment reference from the employer and or a letter of intent from the new employer.
